Alone with my ex

During a coerced meeting with a bitter ex-wife, a Ninth Step emerges

I HAD been sober around six months, and one day my daughter came to a meeting. She said, "I'm going out to visit Mom. I want you to come with me." I had not spoken to my ex-wife in over 20 years. So, I really did not know what to expect.

When we arrived at the house my ex-wife was in the yard working. When she saw me, she did not speak to me. She spoke to our daughter, but the words were for me. She screamed. "I don't want to see that man. I don't want to hear anything he has to say. And if he doesn't leave my property, I'll call the police."

I left there very angry, vowing never to return. The memory of our separation and divorce returned. She had been awarded the kids, house, car, furniture, and anything else of value. I was locked up in jail, I could not appeal in court, and received nothing.

When I returned home I called my sponsor. He said, "Just do AA and leave the rest in God's hands." He reminded me that I had made a commitment when I took the Third Step. "Let Go and Let God," he said.

My sponsor got me busy doing service work, chairing meetings, speaking, and going on Twelfth Step calls with him. He was also with me as I did Steps Four through Nine.

When I'd been sober around 16 months, my youngest son called. We had talked and written to one another while he was in school, and he had now returned home to stay. He said he wanted to see me; I said OK. We met after a meeting, and he said, "We are going out to visit Mom."

I told him what had transpired the last time I had seen his mother. I let him know that I was not going to go through that again. He replied, "It's OK, Dad. I talked to Mom and she said it would be OK."

I said a prayer, we left the clubhouse, and I returned to the home I once owned. I had not been inside the house for over 22 years.

A FIRM COMMITMENT TO UNITY

Former Trustee-at-Large Dean R. presented the following talk on Tradition Nine at a 1998 General Sharing Session

IT is impossible to contemplate that AA, as such, ought never be organized, but when we create service boards and committees directly responsible for those they serve, there are really no rules and no laws; services provided are dictated by the needs of others.

The opening line of Tradition Nine, as reflected in the writings of Bill W. in an August 1948 Grapevine editorial, sets forth: "The least possible organization, that's our universal ideal. No fees, no dues, no rules imposed on anybody."

This statement and definition of Tradition Nine would lead us to believe that AA was operating in anarchy. We all know that is not true. The impossible contradiction works--AA as a whole should never be organized at all. But we proceeded to set up a Conference of recognized and identified areas in 1951 and proceeded to create boards and committees to assist in providing services to alcoholics and AA groups world wide.

It was explained early in my service experience that AA was the most unorganized, organized Fellowship that ever existed, and so it is.

With our informed group conscience, we have throughout the history of AA been able to weather discord and negativism because of our firm commitment to unity, with the underlying knowledge that failure to maintain unity, and pursuing an unsafe course of AA, will lead to its demise and ultimately to the jeopardy of our individual sobriety.

While we do not recognize and have resisted, sometimes violently, the idea of any type of general organization efforts that would hinge on government, we have resolutely and persistently insisted upon organizing special services to assist members of our Fellowship to be more effective and available to carry the message to the still-suffering alcoholic.

The general services that AA provides at the group, district and area level, as well as at the General Service Office, are carried out without authority to order any AA member or group, as they are autonomous.

We make suggestions based on shared experience. We recognize that we cannot dictate to fellow members individually or collectively, and choose not to do so.

AA is truly a society without organization as such; sacrifice is the basis of service, and founded on the spiritual principles, AA is a true Fellowship, with only one purpose--to carry the message of recovery to the alcoholic.

The good will of our Fellowship that we enjoy throughout the world in large measure is directly due to services that we provide through our service structure. May each of us continue to sacrifice in following the spiritual principles and maintaining those principles over personalities and may we continue to carry the spiritual message that was freely given to us so that we may freely pass the AA message on to the suffering alcoholic.

I apologized for my past actions (never mentioning anything she had done). I asked her what I could do to atone for my past behavior.

She said, "Treat your children like a father should. And continue to do whatever it is that you're doing."

On the way home my son said, "Dad, I have prayed for a long time that one day you and Mom would just speak to one another. But I had given up. I knew how Mom was, and you were still drinking. However, when I saw you and Mom talking and laughing I knew it was a miracle and I was filled with a great happiness."

Tears of joy flowed from my eyes. I realized that God had done for me what I could not have done for myself.

Today, I still remember that day. And the countless other days over the past 15 years when all I needed to do was to "Let Go and Let God" work his miracles. James, and First Corinthians, thirteenth chapter.

Room 502 readers tell us about their favorite passages in AA literature

My favorite passage from: Alcoholics Anonymous, (Page 275-276) "The Keys of the Kingdom."

"A.A. is not a plan for recovery that can be finished and done with. It is a way of life, and the challenge contained in its principles is great enough to keep any human being striving for as long as he lives. We do not, cannot, outgrow this plan. As arrested alcoholics, we must have a program for living that allows for limitless expansion. Keeping one foot in front of the other is essential for maintaining our arrestment. Others may idle in a retrogressive groove without too much danger, but retrogression can spell death for us. However, this isn't as rough as it sounds, as we do become grateful for the necessity that makes us toe the line, and we find that we are compensated for a consistent effort by the countless dividends we receive.

A complete change takes place in our approach to life. Where we used to run from responsibility, we find ourselves accepting it with gratitude that we can successfully shoulder it. Instead of wanting to escape some perplexing problem, we experience the thrill of challenge in the opportunity it affords for another application of A.A. techniques, and we find ourselves tackling it with surprising vigor.

The last fifteen years of my life have been rich and meaningful. I have had my share of problems,

heartaches, and disappointments because that is life, but also I have known a great deal of joy and a peace that is the handmaiden of an inner freedom. I have a wealth of friends and, with my A.A. friends, an unusual quality of fellowship. For, to these people, I am truly related. First, through mutual pain and despair, and later through mutual objectives and newfound faith and hope. And, as the years go by, working together, sharing our experiences with one another, and also sharing a mutual trust, understanding, and love—without strings, without obligation—we acquire relationships that are unique and priceless.

There is no more aloneness, with that awful ache, so deep in the heart of every alcoholic that nothing, before, could ever reach it. That ache is gone and never need return again.

Now there is a sense of belonging, of being wanted and needed and loved. In return for a bottle and a hangover, we have been given the Keys of the Kingdom."

I was shown this passage very early in my sobriety, and whenever I need, or someone else needs "A pick me up", I go straight to this passage.

From Party Girl Extraordinaire to Ordinary AA

I first came to AA at 20 years of age, and I lasted 9 months. I still worked in a bar, and I still associated with my old friends. I thought I could do it my way. Eventually at Christmas time I got feeling real sorry for myself, and the old, "Pour me, Pour me another drink" took hold. So again my drinking took over. I lost my children. I knew I couldn't be there for them, and I allowed them to be adopted. Not long after, I committed an armed robbery while drunk, and spent the next 5 years in prison. I'd like to tell you I was sober those 5 years, but like any alcoholic would, I found a way to drink. I got out, and tried to stay sober, but I'd married an alcoholic, so it wasn't to last. Eventually, I moved to Florida from my home in Indiana, and then I began my downward decent into the coldest, loneliest, most horrifying period of my life. I began again, making my living off of my looks, and other talents, and had cards printed up that advertised me as "Party Girl Extraordinaire". Party Girl I was. You were sure to have a good time with me. At least until I got irritated with you, and then I'd probably sock you one, and take your money. When I think now, of all the strangers, I allowed into my room while I was completely out of control on drink, I shudder.

I came again to A.A. after witnessing a boyfriend shoot himself in the head, and die. I know that even as sick as I was of the life I was leading, I was doomed to forget the pain, and drink again if I did not do something. That morning, after his death, I fell to my knees and said, "OK God, you have to help me now because I don't know how to survive this. You must help me". Again, still trying to command and direct, I informed God that he would now be helping me get through this. As if he hadn't had his hand on me all along.

I would like to tell you that I never again picked up a drink, but I cannot. I had to be beaten by the police - AGAIN, and lose most of my hearing as well as my home - AGAIN, before I would again ask for help. The loneliness and sadness I possessed is beyond description, and I need not describe it, for I know you have felt it too. When I first began this journey I felt sure I would return to my old ways. I was not done. But I had some faith that, if I just went to a meeting today, and didn't pick up a drink, then maybe, just maybe I could change my life. I knew one thing. I was happy as hell to be free of the rat race.

I got a sponsor, I did the steps, and I did some service. Sure I broke a few "rules" along the way, but I did not pick up a drink, no matter what. I asked for help, and got it! With the help of many, many people, I now have a home, a job I like with pay that is respectable, my cat, a little car, I now have my brother in my life again, a relationship with a God of my understanding, a beautiful 10 month old daughter, and as of October 11, three years of continuous sobriety. The problems of today are laughable compared to the problems of getting another drink, or even food. I have done a lot of footwork, and still I can tell you that this is the "easier softer way". I am now just an ordinary member of society, and most importantly, of Alcoholics Anonymous.

It's your Birthday!


