# **Step Nine -** "Made direct amends to such people wherever possible except when to do so would injure them or others."

### Beyond 'I'm sorry'

I was just out of rehab and getting involved in AA in my community. I got a sponsor, and I told him about the mess I'd left behind on my last drunken spree. I work as a freelance graphic designer and was in the middle of several projects for an ad agency. It was St.Patrick's Day and I'd decided to tie one on because, after all, I'm Irish-American.

My drinking spree went beyond the holiday and continued for another four or five days. I avoided my wife, daughter, home and work. I went from bar to bar until my ATM card wouldn't work anymore. After I came home I lay in bed, very sick. I kept hearing calls on the answering machine from my client, pleading with me to get ahold of him. I didn't. I did have enough sense to throw myself into rehab with the help and support of my wonderful wife.

I told my sponsor about the jam I'd left my client in by avoiding his calls and the pending projects that I was working on. He suggested that I make amends to the client. I said, "what, walk into his office and apologize? I don't know if I can do that."

My sponsor said, "No, you'll do more than that. You'll walk into his office, apologize, then you'll offer your services at no charge until you make up for the damage you created."

I said, "Uhhh . . . I'll have to think about that."

A couple of weeks or so later, the thought of that amends popped into my head as I was driving home at about 10 in the morning. It became increasingly obvious to me that this was the right time to walk into that office and do what I needed to do. Yikes!

I was scared to death. What if he gets angry with me? what if he throws me out of his office? what if . . . Then I thought of something that might help: praying. I live in a mountain community, and as I was driving up the highway I saw beautiful views below the cliffs. I pulled off the road into a turnout, got out of the car and got down on my knees. I asked my Higher Power to help me and to remove my fear. I asked him for his will, not mine, and to speak his words through my mouth as I made this amends. I finished praying, stood up and turned around. There was a vast, beautiful view as I gazed down the mountainside. I felt very much

## Paving the Way

It's always fascinating to learn just how people came to Alcoholics Anonymous. In my case, I looked AA up in the phone book and called our local central office. Thank goodness, some service board or committee put it there! The person on the other end of the line took my number and had an AA member call me back for the one-on-one, language-of-the-heart introduction that began my incredible journey in sobriety.

At my very first AA meeting, I was warmly greeted and taken to the literature rack at the front of the meeting room. My greeter selected some of the pamphlets for me to take home. I could relate not only to the AA members but to the AA literature as well. Thank goodness, some service board or committee wrote, published, and distributed these pamphlets!

Although I only planned to attend one meeting a week, I went to more because I had a car and some other newcomers didn't. One would call and ask if I planned on going to a meeting that night and I'd say yes in spite of myself. So, I picked up a meeting list which helped us find meetings--where and when. Thank goodness some service board or committee gathered the information, printed and circulated this list!

Many of my AA friends--and yours too, I'm sure--found the Fellowship in a variety of ways, and not a few are due to some kind of service board or committee whose efforts facilitate our Twelfth Step work. Correctional, Treatment, and Hospitals and Institutions committees arrange for institutional meetings and bridge the gap between a facility and an individual AA or a group.

In some instances, a doctor or member of the clergy recommended AA to their patient or parishioner; Cooperation with the Professional Community committees most probably paved the way. Some AA members were exposed to a radio or TV program, not necessarily produced by AA but by someone who has benefited from the work of a Public Information committee. All these dedicated endeavors of service boards or committees make our Twelfth Step work possible.

The preliminary work done by AA service boards and committees directly responsible to those they serve (you and me) is invaluable to the future of the Fellowship. I might not be here today if they hadn't put Alcoholics Anonymous in the phone book!

### Local Readers Share.....

I was your average maintenance drinking drunk. I realized I had to have alcohol to move from deep depression to functioning depression. My dependence caused me to put my need for Alcohol above all others.

After doing my fifth step, my obvious list of amends was in front of me. I had plowed through the lives of those I loved, oblivious of their needs and blind to their importance in my life.

My 9th step was pretty well laid out for me. I had a yeomen's task in front of me. My sponsor helped me divide up the task, starting with the hardest amends, and working backwards. He also made sure my mind was in the right place when I attacked each amends.

At 30 years sober, I was able to hold up my head and face the world. I thought my slate was clean. But then life happened to me. A close friend in AA stopped communicating with me. I asked what I had done, but no response. I felt sad, helpless, and abandoned. I turned this over to my Higher Power, realizing I had done all I could.'

I woke up one morning, from dreaming, and realized I had abandoned some good people when I got sober. These friends drank, but not like alcoholics. I had abandoned them because of my initial fear of being around any alcohol at all! That very morning, I was going to a lecture at Cheekwood in Nashville. I seldom participated in this type of event. I was bored.

I got out of my car, turned around, and there was my friend whom I had dreamed of. It had been thirty years since I had seen she or her husband. She smiled, as did I. I said immediately, "You may not believe this, but I have been dreaming about you!"

She responded in a gracious Southern way...she was flattered.

I explained that I was addicted to alcohol and though I had always thought the world of she and her family, I was initially scared to be around any drinking. That is why I hid from a lot of people initially. We chatted some more. She expressed her appreciation for giving her that piece of the puzzle. She had not understood why I moved away. She wished me good health in my recovery. We went into the Hall and sat together during the lecture.

So many times I find that if I am in a good state of connection with my higher power, the opportunities for amends will present themselves. Grace is given to me if I seek it.



at peace. I really don't know if I had a spiritual awakening that morning, but it certainly felt like something of that nature.

I got back in the car and drove to my client's office, a little more comfortable now. I walked up to the front desk and the receptionist said, "Hi, Rick," as if she had just seen me the day before. I took a seat and had to wait before I entered the bigwig's office. He came out and said, "Hi, Rick. Come on in." I sat down in his office, quickly asked my Higher Power to be with me once again, took a deep breath and began.

I told him that I have a problem with alcohol, that I'd just come out of rehab and that I'm in recovery. I told him that I was fully aware of abandoning my responsibilities to him and the projects, and that I had jeopardized the relationship and reputation between his company and the clients. I told him that I was sorry. He responded with, "I'm so glad that you're taking care of your life. How is your family?" Wow, I thought to myself. He's not as angry as I thought. I then told him that I needed to make up for the mess that I created, and I offered my services at no charge for a couple of work days. He seemed to be caught off guard for a few seconds, then said, "Okay, if you feel that you need to do that." So that's exactly what I did.

I had no ulterior motive when making this amends, nor did I ever expect to work for that agency again. But I have to end this story now, because I need to get back to work on a fairly big project for that very client.

- 8. What has rotation to do with anonymity? With humility?
