## Good Neighbors

My home group met at one of the local clubs in our area. Although we were not affiliated with the club, we rented their meeting room. In early 2007, we learned that the club was closing its location and moving; however, at the time we could not be guaranteed a meeting place at the new location. Our group began to research other possibilities, and we found a meeting place at a church. There was a meditation group meeting upstairs at the same time as our meeting, but the church official did not think this would be a conflict, as long as we were quiet.

As we prepared for the move in March 2007, we began to discuss, in our group conscience, how we would announce anniversaries, and how we would deal with the clapping that goes on during those announcements. Keeping in mind the Fourth Tradition, "Each group should be autonomous except in matters affecting other groups or A.A. as a whole," we concluded that it would be difficult for our group to accept a location in which we might interfere with another group already meeting there—especially a meditation group. We decided to explore other meeting place options.

We found a space near another AA group that met on the same night. The situation was ideal: there would be plenty of room for all who attended our meeting, we could use the facility's coffee equipment, and we would not have to change our meeting day or time. We were very happy with the outcome, and the move took place.

All was going well, and we began to attract a different membership because of the new area. The group grew. We continued to meet every week. Then we heard through the "grapevine" that the other group's members were resentful because our meeting had affected their meeting's attendance considerably; some of their members had begun to leave and come over to our home group. (We met a half hour earlier than the other group, which met

#### **CONCEPT IX**

Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

**Tradition Nine -** "AA, as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve."

## Finding a Voice

Our Ninth Tradition talks a great deal about AA at the Trustee level, which can be intimidating to some AAs. But I'd like to highlight just four words from the long form of this Tradition: "authorized by the groups."

Our operational service structure, as handed over to us AAs by Bill and Dr. Bob, took place with the dawn of our Third Legacy. This Legacy, laid out in our Service Manual, turns over the entire down-the-line authorities of AA to the collective conscience of all the AA groups, which, of course, are comprised of individual members.

Individual members, by becoming active in a group and attending the group's business meetings, exercise their right to be heard in the group conscience. Even a newcomer, joining the group and attending his or her very first business meeting, has a powerful voice in the worldwide affairs of AA.

Regrettably, the group conscience can become lodged in the throat of a group, never getting any further than the church basement. I have witnessed groups becoming just as self-involved and self-centered as any individual AA member who never lifted a chair or made a pot of coffee.

Unless a group is organized enough to have business meetings, a way to reckon its own group conscience, and an active, elected GSR (general service representative) to carry that group's conscience to the district level, such a group could be compared to a member who just doesn't drink, and goes to meetings, but does not work the Steps or become an otherwise active member.

Just as we individuals have the Twelve Steps to maintain our own spiritual fitness, our groups have the Traditions to maintain their primary purpose.

Our groups play an important part in worldwide AA and in carrying its message far and wide. Each member helps shape the group conscience. The group's elected GSR makes sure it's understood at the district and area levels, and that it's part of the delegate's thinking, which he or she takes to the annual General Service Conference of AA. Delegated with the full authority of the groups, the Conference is responsible for developing and maintaining all the services needed to carry AA's message of hope and recovery. At the bottom of our upside-side down organizational structure, the trustees, taking their authority from the Conference, take actions that allow the GSO staff to carry out the day-to-day operation of those services.

literally one block away from ours.) One of our members, who was invited to speak at their meeting, later told us that she could feel the resentment coming from that group.

We began to discuss this issue in our group conscience meetings. It was obvious that we owed that group an amends, as we had never considered how our move would affect it. After some discussion, our group decided that essentially we had broken the Fourth Tradition and that we did owe an amends. But what were we willing to do to make it up to them? Were we willing to move our meeting time if they asked us to? Were we willing to move our meeting night, if that was possible? Would these changes affect our home group members' ability to attend our meeting? All of these questions were discussed at length, and our group concluded that we would be willing to do whatever we needed to do to make things right. Step Eight says: "Made a list of all persons we had harmed, and became willing to make amends to them all." We contacted the secretary of the other AA group and asked permission to attend their group conscience meeting. We were given permission to do so, and four of our home group members attended.

Their group conscience meeting seemed like the longest one I had ever attended, and we were last on their agenda. I was taught that making amends must be brief and concise, so most of my personal amends lasted only long enough to make the amends and leave. This time it really dragged on, but I had no idea of the spiritual awakening the other home group members, and I, would experience. As Step Nine instructs us, we made "direct" amends; then we asked the aggrieved group what we could do to make it right. A long discussion ensued, and their members asked that we change the time of our meeting, so that people could attend both meetings. Their group conscience concluded that the most important goal that both groups could have in mind was the newcomer being able to attend both meetings back to back. This was indeed the Fifth Tradition in action: "Each group has but one primary purpose—to carry its message to the alcoholic who still suffers." We agreed to go back to our group and vote on a new time that would enable members of both groups to attend their meeting and ours.

We voted to move our meeting time. Finally, both groups were happy with the solution we had found thanks to The First Tradition: "Our common welfare should come first; personal recovery depends upon A.A. unity."

Through this experience, I saw how the Steps and Traditions came together for the good of both groups. Ours broke the Fourth Tradition because we were not mindful about whether our move would affect any other group. After we made the amends, the reality of the Fifth and First Traditions came alive for both our groups. We have become closer, we have experienced the Steps and Traditions in action, and many of our members now attend both meetings. The outcome of this experience was better than I could ever have imagined. I definitely felt God working among our groups through the Second Tradition: "For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern." It felt like a spiritual awakening, only this time it was about AA unity, and not about my own personal recovery.
