# My belief your belief

When I was a newcomer, some people were very aggressive in attempting to tell me that my Christian understanding of a Higher Power was a problem. They said I had to abandon my beliefs to accept "AA's concept."

To this day, I don't know what they meant. But this made my initial journey into the program, and the question of God, more problematic and challenging for me than it needed to be. I wondered for a long time if I could still be a Christian and be a part of this AA thing. I have also heard people hammering newcomers with a very specific concept of God, a very Christian-sounding version, insisting that newcomers had to believe in a particular concept of God to be a part of the program.

I learned from my sponsor that my beliefs about God weren't a problem. He helped me through those vulnerable and troubling first months of sobriety. He struggled intensely with his own concept of God and he openly shared those struggles with me. He was an atheist at the time he worked with me, while I was a Christian with a strong faith.

My faith alone, however, was not able to keep me sober. I needed AA.

I never tried to convert my sponsor and he never tried to convert me. He took me through the Big Book. I was desperate to hear what he and the Big Book had to say. We bonded over that mutual connection that the disease of alcoholism creates in us. For me, my faith and understanding of a Higher Power was strengthened, as was my faith in AA and in the Twelve Steps. His work with me has helped my own program of sobriety give fruition to the Promises presented in the Ninth Step.

I can't say what happened for him on the God-front but he always shared with me how much he valued our time together. We are good friends to this day. I got to give him *(continued on page 3)*

# **Anything to Be Cool**

I am a twenty-two-year-old recovering alcoholic. I began drinking and taking drugs when I was fourteen years old. It was the year 1994 and the rebellious songs of Green Day and Offspring surrounded the world of the fourteen-year-old. We were a generation inspired by the skater crowd, the nineties version of the sixties' greasers and the eighties' punk rockers. To be in the cool crowd, you had to wear clothes eight sizes too big, walk cool, smoke cigarettes and pot, and drink beer. In those days, I would have jumped off a 100-foot cliff if it meant I could be considered cool. Drinking a petty beer or smoking a little joint was an insignificant hurdle for me on my road to social acceptance. After all, I was invincible and the worse the action, the more attention I would receive. I attended the Drug Abuse Resistance Education (D.A.R.E.) classes and sat through countless drug-prevention speeches, but those did not apply to such a cool rebel without a cause.

Just eight years later, I found myself unable to complete the simplest of tasks without an anxiety attack or to stick with a job for more than two months before getting fired for my habitual tardiness. Today, with the help of the program of Alcoholics Anonymous, my life consists of re-learning how to complete a full day without acting on my impulses. I am bombarded with feelings of pain and strife that I cannot even begin to explain. I have watched this disease take the life of my aunt and destroy the lives of my mother, grandparents, uncles, and cousins. To this day, I am amazed that you can watch a loved one die a slow and painful death from alcoholism, only to go home at night and consume the same death potion yourself. Most of all, I am saddened by the ignorance and denial in our society.

I believe that it is only through my willingness to completely turn my life over to AA that I have the chance of recovering a life of any value. This is a program that has not only saved millions of lives, but has single-handedly reshaped and almost eliminated the absolute helplessness that this willing-to-recover alcoholic used to experience. This is a program that, through faith and action, slowly allows an alcoholic to recover from spiritual, physical, mental, and financial bankruptcy.

Alcoholics Anonymous, I believe, is built on the foundation that no matter what one's religion, race, creed, gender, or degree of hopelessness, its members will do anything in their power to help. Therefore, I can walk into a meeting anywhere in the country and find a room full of the broke and the rich, the powerful and the powerless, the famous and the ordinary citizen. Anonymity makes us all equal and everyone feel welcome. This anonymity is what gave me the courage to walk through those doors. It's what gives me the strength to keep coming back.

his seven-year sobriety chip soon after he had to disconnect his brother from life support. His brother was an alcoholic who was unable to get the message of AA.

I sponsored a lot of guys. Of those guys, the only one who is still sober, to my knowledge, was an atheist when I started working with him. He was still an atheist when he moved away from Sacramento and got a new sponsor. We struggled with the Third Step. I let him explore his reactions to the concepts presented in the Big Book. I didn't try to convert him. I listened to what he had to say, just as my sponsor listened to me.

I don't know where my old sponsee stands on God now, but I have watched the Ninth Step Promises come into his life. He participates in service work and helps others to get sober and stay sober.

To this day, I believe my experience with my sponsor, and my only sober sponsee, send an important message about this very contentious issue of spirituality in the program. I believe that it is of paramount importance to honor and give space for the process that each person must engage in to work through the issue of faith and a Higher Power in AA. To me, a critical aspect of the program is presented in the words, "God, as we understand Him."

The program presents us with a question and then leaves a nurturing space for us to examine and investigate the question. I believe that it's more important for our sobriety and for our relationship with a Higher Power to sincerely examine and explore the question and the concept of God than it is to come to any particular answer.

As a faithful Christian, I'm not threatened by other conceptions of God, nor do I think a person's program of sobriety is compromised by a different understanding of God than mine, even if it's simply a "Group Of Drunks" or "Good Orderly Direction." As my understanding of the program teaches me, I judge a person by their works. If someone is working with others, carrying the message and reaching out to newcomers, I see an understanding of God that works.

I've met people all across the spectrum on the God issue. These are people who have overcome many challenges in their own lives and yet have made a potent impact in the lives of others. I have witnessed the Ninth Step Promises come to fruition for individuals representing all dimensions on the spectrum of faith. I have to believe what my experience tells me, that the founders of AA were wise to include "as we understood Him," in the Third and Eleventh Steps. These words create an important part of the recovery process: The nurturing space to explore the question of God within oneself.
