## **Divorcing the Demons**

My biggest demon has always been fear, which pursued me with a vengeance. I drank alcohol to silence the relentless voices. The pain led me to AA where I eagerly crawled aboard the lifeboat. I'd been paddling in my rowboat for forty-three years, screaming for someone to bring me the other oar and teach me how to row myself into the coursing current of life. With the love of the people in AA, and the Steps, I learned to chart my way into happier waters. Recently, I celebrated twenty-six years of sobriety. But it hasn't been all smooth sailing.

For seventeen years after I stopped drinking, a recurring uneasiness robbed me of joy. Valiant attempts to clear destructive character flaws faltered. Like weeding the lawn, I pulled out the top parts but left the deeply imbedded roots. Invariably the weeds of resentment, anger, and pride grew back.

Fears finally erupted with volcanic force. On my sixtieth birthday I sat in a psychologist's office, suffering from acute depression and agoraphobia.

A few days earlier I'd stopped at the supermarket to buy a turkey and fixings for my group's eighteenth anniversary, when a wave of panic washed over me. Feeling so shaky that I became faint, I grabbed my purchases and fled. At home I feared another panic attack, while just thinking of leaving home paralyzed me. Fears crouched in every corner like coiled snakes. The thought of driving or riding in a car was a night-mare--I was haunted by the thought that I would fling myself out onto the highway. Jumping into a bottle, however, wasn't a viable option for me.

Thus began my journey into taking a deeper look at all the yetunresolved fears, and the guilt, perfectionism, control, criticism, and pride that were keeping me from being happy. I discovered my way of thinking caused my panic attacks and that I could change my thinking. This involved uncovering old ideas and doing a lot of deep soul-searching. Pain had prevented me from doing it earlier. Now, painful as it was, I knew it was the only way out of my dilemma.

Fear was like my Siamese twin; I needed to sever our togetherness. By discovering the origin of my fears, dissecting them and working through them, I defused them.

Thus began my journey into taking a deeper look at all the yetunresolved fears, and the guilt, perfectionism, control, criticism, and pride

## On the 5th Tradition

Says the old proverb, "Shoemaker, stick to thy last." Trite, yes. But very true for us of AA. How well we need to heed the principle that it is better to do one thing supremely well than many things badly.

Because it has now become plain enough that only a recovered alcoholic can do much for a sick alcoholic, a tremendous responsibility has descended upon us all, an obligation so great that it amounts to a sacred trust. For to our kind, those who suffer alcoholism, recovery is a matter of life or death. So the society of Alcoholics Anonymous cannot, it dare not, ever be diverted from its primary purpose.

Temptations to do otherwise will come aplenty. Seeing fine works afoot in the field of alcohol, we shall be sorely tempted to loan out the name and credit of Alcoholics Anonymous to them; as a movement we shall be beset to finance and endorse other causes. Should our present success continue, people will commence to assert that AA is a brand-new way of life, maybe a new religion, capable of saving the world. We shall be told it is our bounden duty to show modern society how it ought to live.

Oh, how very attractive these projects and ideas can be! How flattering to imagine that we might be chosen to demonstrate that olden mystic promise: "The first shall be last and the last shall be first." Fantastic, you say. Yet, some of our well-wishers have begun to say such things.

Fortunately, most of us are convinced that these are perilous speculations, alluring ingredients of that heady new wine we are now being offered, each bottle marked "Success"!

Of this subtle vintage may we never drink too deeply. May we never forget that we live by the grace of God--on borrowed time; that anonymity is better than acclaim; that for us as a movement poverty is better than wealth.

And may we reflect with ever deepening conviction, that we shall never be at our best except when we hew only to the primary spiritual aim of AA. That of carrying its message to the alcoholic who still suffers alcoholism.

that were keeping me from being happy. I discovered my way of thinking caused my panic attacks and that I could change my thinking. My wounded pride winced at the thought of being so fearful I couldn't drive for a while. One of my sponsees drove me to meetings. What a wonderful demonstration to me of how much false pride I'd possessed.

When I discerned I was the one who made me feel guilty, I divorced my lifelong companion guilt (though not without the pain that separation from an old friend can cause). The reward: I no longer have to punish myself with guilt.

I unearthed my perfectionism and decided I liked being human. Now that I had become "entirely willing," I could see that my need for approval had grown into people-pleasing.

Control isn't easy to spot but I'm doing less of it.

Judging and being critical were a major part of my background. But I learned that judging others was only a sign of my low self-worth. Finally, I heard what AA tried to teach me--that when I stand in judgment, the person I judge most harshly is myself.

Today, I'm grateful for the incapacitating agoraphobia I experienced because it forced me to deal with my character flaws and move toward the potential that God has for me. My previous efforts at housecleaning in Steps Four and Five had left a lot of cobwebs and dust which obstructed my view of the true picture. My denial and fear kept me from changing what needed to be altered. The process has been slow. But I don't have to strive for spiritual perfection, just spiritual progress. Instead of wondering why it took me so long to face the monsters, I'm grateful that at last, with God's help, it's possible.

Had I not faced the demons, I could have lost my life by drinking again. My happy sobriety today is due to a thorough housecleaning. Once I turned and faced my fears, I could walk away happy, joyous, and free.
